

PUBLIC NOTICE FOR E-AUCTION – SALE OF IMMOVABLE PROPERTY**(Under Rule 8 (6) read with Rule 9 of the Security Interest (Enforcement) Rules, 2002)**

Mr. Vishal Ashokkumar Karkera (borrower)** by virtue of Deed of Assignment dated **25.03.2021**, executed with original lender Bharat Co-operative Bank (Mumbai) Ltd, whereby ASREC (India) Ltd., in its capacity as trustee of ASREC PS-12/2020-21 Trust, has acquired the financial assets of aforesaid borrowers from Bharat Co-operative Bank (Mumbai) Ltd with all rights, title and interest together with underlying security interest under Section 5 of the SARFAESI Act, 2002.

The Authorized Officer of Bharat Co-operative Bank (Mumbai) Ltd. in exercise of powers conferred under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (SARFAESI) and Security Interest (Enforcement) Rules, 2002, had issued a demand notice dated 16.11.2018 u/s 13(2) of the said act calling upon the **1. M/s. K' Scope Entertainment Pvt Ltd.** (hereinafter referred to as "the Borrower") and **Mr. Vishal Ashokkumar Karkera**, **Mr. Kushal Prem Shrivastava** (Directors and Joint/ Co-Borrowers) in their capacity for repayment of total outstanding amount aggregating to **Rs. 51,47,719.00** (Rupees Fifty-One Lakhs Forty-Seven Thousand Seven Hundred and Nineteen only) & **2. Mr. Vishal Ashokkumar Karkera** (hereinafter referred to as "the Borrower") and **Mr. Bantwal Praveenchandra Kulal** (Surety) in their capacity for repayment of total outstanding amount aggregating to **Rs.2.44,86,490.00** (Rupees Two Crore Forty-Four Lakhs Eighty-Six Thousand Four Hundred and Ninety only with further interest thereon in respect of the advances granted by the Bharat Co-operative Bank (Mumbai) Ltd. to **1.M/s. The said Demand Notice dated 16.11.2018 under Sec.13 (2) of the said Act served upon you and in exercise of the powers conferred under Section 13(4) read with Enforcement of Securities (Interest) Rules, 2002, the Authorized Officer of Bharat Co-operative Bank (Mumbai) Ltd took symbolic possession of the property more particularly described in Schedule here under on 25.10.2019.
