However, the intending bidders should make their own independent inquiries regarding the encumbrances, title of the properties put on auction and the claims/ rights/ dues/ affecting the property, prior to submitting their bid. 7. The Bid price to be submitted shall be at least one increment over and above the Reserve price and bidders are to improve their offer in multiples of Rs. 25,000/- (Rupees Twenty Five Thousand only) for properties listed above.
